



THE COVID-19 RAPID ANTIGEN TEST EQUIPMENT

(FAQ for CAMFEBA members)

Q1. Who can purchase Covid19 Rapid Antigen Test equipment (Rapid Test) from the Ministry of Post and Telecommunications (MPTC)?

- ⇒ As stated by the MPTC illustrates that only the following Public and Private sectors are entitled to purchase the Rapid Test:
- For Ministries/Institutions, are required to have an order request letter by determining the specific amount in proportion to the number of its subordinates.
 - For companies or Private Institutions, are priorities for locations that have a great number of employees-workers and located in high-risk areas related to Covid-19. To define or find out which areas high-risk areas, please check with your competent authorities namely your located authorities, Ministry of Health and such.
 - Based on our verbal communication with the MPTC's official explain that companies/private institutions (legal entities) that employ more than 100 workers-employees are eligible to place its order for the rapid test. On the other hand, for legal entities that have less than 100 workers-employees, are subject to the MPTC's evaluation.
 - For companies/private institutions that request an order, please provide the following information:
 - Buyer name
 - Company/Institution Name
 - Total number of workers-employees
 - Order quantity
 - Contact phone number

Q2. Can the general public purchase the Rapid Test for personal use?

- ⇒ As explained by the MPTC's official demonstrates that the general public cannot purchase the rapid test for now because in case of doubt, the general public may get the sample test of Covid19 at the locations at which the Ministry of Health or authorities have determined.

Q3. How to order the Rapid Test?

- The legal entities that are stipulated in the Q1 may order the Rapid Test with the following options:
 - Hotline: 123 / 067 818 782 / 017 848 108 / 077 867 957
 - Or visit mptc.gov.kh/rt. Note: based on our verbal communication with the MPTC's official explain that legal entities' representative may also place an order via telegram chat with the MPTC's hotline above (except 123).
 - Working Hours: 08:00am - 12:00pm and 2:00pm - 5:00pm

Q4. How to make a payment to the MPTC?

After receiving confirmation of the order quantity, the purchaser shall make a payment to the MPTC via the 3 following banks:

Q5. Where to receive your order product (Rapid Test)?

The Purchaser shall go to pick up its order product (rapid test) at the Ministry of Post and Telecommunications.
