Cambodia and Turkey have resolved to further enhance bilateral economic ties. On February 22, a Cambodian Economic Diplomacy Coordinating Team (CEDCT) led by Advisor to the Prime Minister **Prak Phalla** and Member of CEDCT and High Representative of Deputy Prime Minister and Minister of Foreign Affairs and International Cooperation **San Chanrithy** met with a Turkish delegation led by the **Foreign Economic Relations Board (DEIK)** in Phnom Penh.

The meeting's theme was "Investment and Business Opportunities in Cambodia," which included promoting Cambodia's new Investment Law, trade, tourism, and cultural exchanges. It also enables Turkish businesspeople and investors to learn about and explore new opportunities offered by Cambodia as a result of expanded market access, recent bilateral and multilateral free trade agreements, the success of Cambodia's vaccination campaign, and the tourism recovery framework, particularly through the reopening of the country to vaccinated visitors.

Agriculture / 100sq km agriculture hub launch in northern Kampong Speu

**HLH** Agriculture (Cambodia) announced the inauguration of the **Cambodia-Singapore Agricultural Hub** (CSAH) in the northwest of Kampong Speu and the establishment of a memorandum of understanding with the Singapore Manufacturing Federation (SMF) to attract foreign players to invest in the project.

This 100km2 agricultural hub was inaugurated on 18 February at a ceremony attended by many investors, and the project could see the light of day in a few years. The objective of this agricultural hub is to make the city an "eco-agricultural city", the project is divided into 16 zones designated for agriculture, livestock, animal feed production, private land, shared housing, mining, and industry.

# **Brunei / Cyber security upgraded**

**U**nified National Networks (UNN) has launched **DDoS Defence**, a fully managed and automated Cybersecurity Service aimed at protecting local businesses from harmful threats and ensuring that online services are not disrupted by Distributed Denial of Service (DDoS) assaults.

DDoS Defense is the first offering from UNN's curated Cyber Security product and service portfolio to assist the government's commitment to realize **the Smart Nation's Digital Economy Master Plan 2035**.

DDoS assaults on Brunei firms might also be carried out by botnets coming from outside the nation, not merely within Brunei.

According to UNN, these findings indicate that local firms are vulnerable to DDoS assaults as long as they are linked to the internet. Due to the unavailability of their online presence, firms may suffer financial losses, brand reputation harm, and even company failure as a result of DDoS assaults. As a result, local firms should start thinking about implementing a mitigation plan as part of their Business Continuity Plan to defend themselves from DDoS assaults.

The group's job is to talk about the regulations and details of cross-border power sales. Solar power exports will need Indonesia and Singapore to harmonize their power sector rules, according to IESR executive director **Fabby Tumiwa**.

# **Thailand / PTT with record \$3bn profit**

**PTT**Thailand's net profit is a figure of more than 3 billion dollars, with the oil and retail sector accounting for only 2% of this profit. This profit comes mainly from natural gas, oil exploration, and production and its petrochemical and refining activities. More than 100 billion baht of the profit will be used to pay down debt, inject funds into its businesses, invest under the company's plan and manage corporate social responsibility programs.

The company is also developing projects to help people cope with covid-19 such as supporting medical supplies.

This project aims to improve the management of solid waste and plastics in selected cities across Cambodia such as Siem Reap city (Siem Reap), Chbar Mon city (Kompong Speu), Ta Khmau (Kandal), Battambang city (Battambang), and Sihanoukville city (Sihanoukville) that are expected to (1) demonstrate improved solid waste management practices that are adaptable and scalable to other cities in the country; (2) support the Solid Waste Management Law and Policies; (3) promote capacity

building at both national and municipal levels. The project will support improvements in waste collection, transportation, and rehabilitation through processing, recycling, and disposal.

# **Notification / Census of factories and enterprises across the Kingdom**

**The** Ministry of Labor and Vocational Training issued a notification to inform all factory owners or directors that the Ministry of Planning will visit factories and enterprises from **March 1, 2022**, onwards to collect updated information about the economic situation in Cambodia in all sectors (industry and services) gender equality, type of business, the financial status of the economic entity, number of enterprises (micro, small, medium and large), number of the labor force (workers) and other information based in the villages, communes, cities, districts in **25 provinces**.

The Ministry is optimistic that all factory owners or directors will co-ordinate with census officers from the Ministry of Planning to conduct interviews and statistical data at factories with high efficiency.

Prak Sokhonn, Deputy Prime Minister, Minister of Foreign Affairs, and International Cooperation of Cambodia, paid an official visit to the Federal Republic of Germany to further strengthen the bilateral ties, expand cooperation with ASEAN and the Indo-Pacific region, and discuss on the climate change among others. Cambodia is committed to working closely with Germany to combat climate change and value its support in developing a National Adaption Plan (NAP) in cooperation with the GIZ, increasing renewable energy to 25% of the national integrated energy sources by 2030 and becoming carbon neutral by 2050.
